STANDING ORDER NO. 7

Sub:- Programme for the Practical Training of I.P.S. Probationers of Rajasthan (as approved by the Government of India under Ministry of Home Affairs, Letter No. 2/33/55/ALS(I) dated the 17th January 1956 under Sub-rule (2) of Rule 5 of the Indian Police Service (Probation) rules, 1954) for the second year of their probation in this State.

The following training is prescribed for I.P.S. Probationers when they report here after completing their training at the Central Police Training College, Abu and Military Training :

2. Details of the above periods of training would be as follows :

(A) P.T.S. Kishangarn. Here the Probationer would be taught chiefly the local Police Act and all other local Acts which a Circle Officer has to refer to during the course of his work. In addition, the Probationer will do parades and also play games. He will work in turn as the Weekly Officer and look to the administration and discipline in the P.T.S. subject to the control of the Principal. He will moreover learn the local Accounts Rules, Pension Rules, T.A. Rules etc.

(B) In charge City Police Station. The Probationer will actually work as the Sub-Inspector in charge of the Police Station but will no doubt be guided constantly by the senior S.I. in charge. He will distribute pay, attend parades twice a week, perform night rounds once a week, investigate offences, take roll call, distribute duties amongst the Policemen etc. In short he will do every duty which a Sub-Inspector in charge of the Police Station has to do.

(C) In charge rural Police Station. As above, but here he will have to visit villages as part of his tour programme.

(D) With the Prosecuting Inspector or Sub-Inspector:
The Probationer will attend court every day with the Prosecutor and watch trials of cases. He will also assist the Prosecutor by reading the case papers and drawing up points for his use. During this period he will attend parades and do night rounds as above.

(E) S.P.'s office. The Probationer will sit in the various branches of the S.P.'s office as directed by the S.P. from time to time. The S.P. will show him as many papers as possible and advise him as to the way in which they are disposed of. The S.P. will also give correspondence to the Probationer and ask him to study and put up notes on them for the S.P.'s perusal. During this period the S.P. will inspect one Police Station and one Out Post along with the Probationer. Parades and night rounds to be done as above. The S.P. will take the Probationer with him to conferences and meetings and also to the Orderly Rooms which he will hold either in the Lines or in Police Stations.

(F) With an experienced Circle Officer. The Probationer will move all the time with the Circle Officer and learn his work from him from beginning to end. He will write crime registers, read case diaries, attend to correspondences etc., but all this will be done under the supervision of the Circle Officer. He will also visit serious offences along with the latter and see how crimes are to be investigated and supervised. He will also attend parades and do night rounds with the C.O. He will visit Police Stations with the C.O. During this period the C.O. will inspect at least two Police Stations and two Out Posts along with the Probationer.

3. During the two periods (E) & (F), the Probationer will attend the trial of two Sessions Cases from beginning to end.

4. In the last month of this training i.e., the 10th month, the Probationer will take the examination prescribed by Rajasthan Government in their No. D. 4956-Appnt(A)/55 dated 27-6-1955 issued by the Appointments Deptt. (A).

5. During this period of 10 months, the Probationer will write weekly diaries which he will forward to the Range D.I.G. ~~will~~ through proper channel. The D.I.G. will closely supervise his work and guide him as and when necessary.

6. If the above training is completed successfully by the Probationer, he will be appointed as an Independent Circle Officer in some District.
