STANDING ORDER No.1/75

Jaipur, dated the January '75.

In exercise of the powers vested in the Inspector General of Police under rule 26(2) of the Rajasthan Police Subordinate Service Rules, 1974. The following amendments are made in the various Syllabi of Qualifying examinations for promotion (due to promulgation of Criminal Procedure Code, 1973)

↳ pertaining to syllabus for promotion of Const. (CP) to HC(CP)

- 1) In appendix 'A' of Standing Order No.7 dated 26th July, 1966 against the existing entry (b) Criminal Procedure Code, the following substitutions be made:
 - b) Code of Criminal Procedure 1973 (following sections only).
 - i) Chapter V Sections 41, 42, 45 to 53, 55, 57 and 60 only.
 - ii) Chapter VI whole.
 - iii) Chapter VIII Sections 107 to 110
 - iv) Chapter X Sections 129, 144 to 147
 - v) Chapter XI Sections 149 to 153.
 - vi) Chapter XII Sections whole.
 - vii) Chapter XXIV Sections 306, 309 only.
 - viii) Chapter XXVII Section 360 only.
 - ix) Chapter XXIX Section 373 only.
 - x) Chapter XXXIII Sec. 436 to 443 and 446(5).
 - xi) Chapter XXXIV Section 457 only.

- 2) In appendix 'A' at item No. IV which is the Syllabus for Qualifying examinations of Head Constables (Armed Police) for selection for promotion cadre course for promotion to the posts of Sub-Inspectors of Police (Armed Police), issued vide Standing Order No.9 dated 17th Aug. '66 under head written tests at Item (ii) against the existing entry, the following shall be substituted:-

(ii) Code of Criminal Procedure, 1973 (following only)

- i) Chapter V
- ii) Chapter VI
- iii) Chapter X - Sections 129, 132 and 144 only.
- iv) Chapter XI Sections 149 to 152.

- 3) No change is indicated in the following Syllabi:

- i) ~~For promotion of~~ Syllabus for qualifying examination of Constables (Armed Police) for selection for promotion cadre course for Head constables (Armed Police).

- ii) Syllabus for qualifying examination of Head-constables and Assistant Sub-Inspectors of Civil Police for promotion to the posts of Sub- Insps. of Police (Civil Police).


