STANDING ORDER NO. 2/1988.

Subject :- RECRUITMENT OF CONSTABLES IN CIVIL POLICE/ARMED POLICE/R.A.C.

In supersession of Standing Order No. 10/1976 and all previous Circulars issued from time to time on the aforesaid subject and read with Standing Order No. 4/1985 and Standing Order No. 4/1986, the following policy is laid down for reviewing the recruitment of Constables in Civil Police (including I.B.) / Armed Police/Rajasthan Armed Constabulary to ensure elimination of sub-standard and deficient recruits from the Police Force:

- (1) The recruitment board constituted under the Rajasthan Police Subordinate Service Rules, 1974 for recruitment of Constables will ensure that no sub-standard person is recruited as Constable. In case, any relaxation is required in chest measurements of any candidate found otherwise suitable and particularly useful, recruitment board shall forward its recommendations to I.G.P. Headquarters for obtaining orders of the D.G.P. Only exceptional cases would be considered for relaxation who possess proficiency in games and sports and hold N.C.C. Certificates. This will also be applicable to recruitment of sons of serving or retired Police personnel as a gesture of police welfare.
- (2) After preparation of the list of candidates who are found suitable for undergoing medical examination as laid down in Standing Order No. 4/1986 dated 2.6.1986, the concerned D.1.8; Ranges/R.A.C./Units/Office will proceed to the District/Unit Headquarters concerned and verify to his satisfaction the physical standards of candidates as prescribed in Rajasthan Police

Subordinate Service Rules, 1974. In case any candidate is found sub-standard, the D.I.G.P. will direct the Chairman of the recruitment board to remove his name from the said list of candidates. Thereafter, the customary procedure of sending the selected candidates to the Medical Officer for medical examination and issue of certificate be undertaken. No screening of physical/medical standards by departmental officers will be conducted after issue of appointment orders of candidates.
