During attachment to Police Stations, independent charge will be given to trainee and SHO will be sent to another place for that duration. During attachment to C.O. office, independent charge will be given to trainee and C.O. will be sent to another place for that duration.

Advanced Professional Skill Enhancement Course at R.P.A. (Phase-II)

Trainees after completion of 28 weeks of practical training in respective districts shall undergo advanced professional skill enhancement course for 4 weeks at R.P.A. There will be intensive training on certain subjects pertaining to Police Practical works.

Mid-term Examination:

During institutional training at R.P.A., there will be a mid-term examination for both Indoor and Outdoor subjects. This examination will be held on completion of four months of training. The mid-term examination will be conducted by a board appointed by the Director, R.P.A. in both Indoor and Outdoor subjects. Marks obtained in this examination will carry 30% weightage in compilation of final result of the training.(Previously the mid-term examination carried 20% weightage.)

Final Examination:

A board comprising of one ADGP as Chairman, two Dy.IGP as member and Dy. Director, R.P.A. as member Secretary, appointed by the D.G.P., Rajasthan will conduct the final examinations before conclusion of training at R.P.A. for Indoor paper I to XII and Outdoor subjects I to VIII. As indicated above the board will award marks out of remaining 70% marks in this examination. While compiling the results, the score from 30% marks will be added based on the probationer's performance in mid-term examination. Director's assessment shall carry 100 marks.

Examination Result:

Passing marks in each subject will be 45% and total aggregate for passing the exam, including the director's assessment will be 50%. For qualifying subjects the pass marks will be 40% in each subject. There will be no grace marks. Trainees who fail up to two subjects in the final examination will be given one chance to reappear in those papers in a specially conducted reexamination but those who fail in more than 2 subjects will be called for a special training course at RPA for 3 months. The case of confirmation of such officers shall be moved to the government accordingly. If the officer fails in the re-examination also after the special training course, his case will be referred to the government for necessary decision.

Confirmation:

The confirmation test will be held after the Advance Skill Enhancement Course (Phase II) at RPA. The trainees shall be examined in two papers of 50 marks each. The first paper will be of assessment of field training record and the second paper will be of viva – voce about field training and topics covered in the II nd Phase of training at RPA. This exam shall be qualifying in nature.
