Board Examination:

A Board comprising of one IGP as chairman, two Dy. I.G.P. as member and Dy. Director, R.P.A. as member Secretary, appointed by the D.G.P., Rajasthan will conduct the final examination before concluding of training at R.P.A. for Indoor paper I to VI and Outdoor subjects I to IV.

Examination Results:

Passing marks in each subject will be 45% and total aggregate for passing the exam, including the director's assessment will be 50%. There will be no grace marks. Those who fail in one or two subjects in the final examination will be given a chance to reappear in the same paper/papers in a specially organized re-examination within 3 months, but those who fail in more than 2 subjects will be called for undergoing a special training course for 3 months. For extending probation period of such officer in above situation, the case will be moved to the government accordingly. If the officer fails in the re-examination also after the special training course, his case will be referred to the government for necessary decision.
