**G.S.R.113** .-In exercise of the powers conferred by section 4 of the Rajasthan Epidemic Diseases Act, 2020 (Act No. 21 of 2020), the State Government hereby makes the following amendments in regulations issued by this department's even number notification dated 03.05.2020, published in Gazette vide GSR 113 dated 03.05.2020, as amended from time to time, with immediate effect, namely:-

#### AMENDMENTS

In the said regulations,-

(i) the existing regulation 7 shall be substituted by the following, namely:-

“7. No person shall organize more than one function for any marriage and he shall submit prior intimation of such function in writing, preferably through e-mail to the Sub-Divisional Magistrate having jurisdiction over the place of marriage related function. Such intimation must contain the time slot of three hours, date, list of participants and venue of marriage. In such function organizer shall ensure that –

- (i) total number of participant should not be more than 31, excluding count of Baza vada (Band Players);
- (ii) above function shall be completed within 3 hours;
- (iii) social distancing should be maintained during the function;
- (iv) every participant of function shall mandatorily wear face mask properly, 'No Mask No Entry' will be strictly followed;
- (v) screening of every participant shall be done and proper hygiene shall be maintained. Provision for thermal scanning, hand wash and sanitizer should be made at all entry and exit points and in common area;
- (vi) common facilities and all points which come into human contact e.g. railings, door handles etc. should be frequently sanitized;
- (vii) Marriage organizer should make or arrange for videography of the function/ceremony and same shall be made available on demand by the Sub- Divisional Magistrate concerned."

(ii) after the existing regulation 7 and before the regulation 8, the following new regulation 7A shall be added, namely:-

"7A. No Proprietor/Owner/Manager/Occupier of venue of marriage shall allow to organize any function/ ceremony in violation of regulation 7 above."
