ORDER

The State Police Accountability Committee has been established under the Chairmanship of Retired Rajasthan Higher Judicial Service Officer, Shri H. R. Kuri, along with three private members and Member Secretary (Add. Director General of Police, Vigilance) by this department's order of even Number dated 14.10.2022 (revised vide orders dated 01.11.2022 & 19.12.2022), as per provision of section 62 of Rajasthan Police Act, 2007. The terms and condition of appointment of the Chairman of the committee will be as given below:-


- 1. Salary- last pay minus pension
- 2. DA.- on net pay
- 3. HRA.- House rent allowance shall be admissible on last pay drawn subject to the condition that the re-employed retired employee produces an affidavit to the effect that he/she or his/her spouse has no house in their own name or no accommodation is provided by Central/State Government or any of their Public Sector Undertaking to his/her spouse at the place of re-employment.

or

Rent free Government accommodation.

- 4. Medical Facility as admissible to retired RHJS.
- 5. Transport Facility.- Department will provide transport facility (Car SX4 or Bolero with Driver)
- 6. Air Travel executive/Business Class
- 7. Leave.- In the case of persons re-employed after retirement, the provisions contained in the Rajasthan Service Rules regarding leave and leave salary shall apply except the following:-
 - 1. Encashment of balance of PL during the period of re-employment
 - 2. Encashment of balance of PL on expiry of re-employment
 - 3. Medical Leave.







The members of the Committee will be allowed Honorarium/Sitting Fees and allowances as under:-
