#### Note:-

- 1. HM means Minister Jail, ACSH means Addl. Chief Secretary, Home. HS means Secretary Home, SHL means Secretary Home (law), JS means Joint Secretary, Sr. DS means Sr. Deputy Secretary, DS means Deputy Secretary, Sr. AO means Sr. Accounts Officer and GO means Group Officer, or Officers holding charge thereof.
- 2. Cases falling in the category as laid down under Rules of Business will be submitted to the undersigned through Addl. Chief Secretary, Home.
- 3. Cases mentioned at Serial No. 28, 29, 30 and 32 will be submitted to the undersigned through HS/ACSH/CS.
- 4. Matters required to be presented before cabinet as per rule 17 of Rules of business shall be submitted to the undersigned through HS/ACSH/CS.
- 5. All Policy matters relating to department will be brought to the notice of MOS/HM depending upon the importance of the matter.
- 6. All cases considered important by the Secretary Home/Joint Secretary/Sr. Deputy Secretary/Deputy Secretary Group Officer will be brought to the notice of the Addl. Chief Secretary, Home.
- 7. Cases ordinarily to be disposed of by the Jail Minister will be disposed by ACSH, in the absence of the Jail Minister from the headquarters, provided that the case is of such a nature that it cannot await the arrival of the Jail Minister. However, such decision should be confirmed by the Jail Minister later on. Similarly, where ACSH is out of station or out of office, cases to be decided by Jail Minister will be submitted by HS directly to Jail Minister.
- 8. Cases to be disposed of by HS, in his/her absence, will be disposed of by ACSH.
- 9. Matters of Accounts (Group-2) related to Group-XII Jail will be routed through DS/JS.
- 10. Cases not covered by the above items will be examined by Group Officer and put up to Jail Minister through ACSH for orders.
- 11. All the Officers may ensure the compliance of Administrative Reforms Group-D Department Order F.6(2)AR/Gr.1/14 dated 17-03-2015.
