**ORDER**

Sub: Addendum to Implementation of Lock Down order dated 26.03.2020.

Based on the clarifications received from Ministry of Home Affairs, Government of India in the form of Addendums to the Guidelines issued, **the following further implementation guidelines are issued clarifying the activities that are permitted** during the lockdown:

**1. "ESSENTIAL GOODS"**

The definition of essential goods conveyed earlier – shall also include items of daily use like hygiene products such as hand washes, soaps, body wash, shampoos, creams, powder, tooth paste / oral care, sanitary pads, diapers, disinfectants, surface cleaners, detergents, charger and battery cells etc. and all such products that are ordinarily available at a grocery or provision store. Similarly, food products will include all kinds of food products, including condiments, spices, various kinds of cooking sauces, cheese etc.

**All activities** related to the above products and connected units / establishments with the supply chain are permitted – which include **sale through shops or e-commerce / home delivery companies, manufacturing units, godowns / ware housing**, transportation, , as well as the **personnel required** for the sale, godown, labour for loading, transportation etc. are permitted.

**2. "HOME DELIVERY / E-commerce Companies**

All e-commerce / home delivery companies supplying essential items / goods be permitted. This includes their offices, ware houses and home delivery persons.

**3. AYUSH (Ayurved, Unani, Homeopathy etc.)**

- i. All AYUSH services – sale and distribution of drugs, hospital dispensaries, individual clinics and telemedicine facilities.



- ii. Manufacturing of AYUSH drugs and the supply chain including raw material and packaging.

#### **4. Agriculture & Horticulture**

##### **All activities – direct and related – permitted**

These also include:

- i. Shops selling any Agriculture or Horticulture related items like seeds, fertilizer, pesticides, agriculture equipment, and other items of supply chain.
- ii. Shops dealing with spare parts & repair of farm machinery and equipment.
- iii. Manufacture of farm machinery and equipment, spare parts and all items of the supply chain
- iv. Manufacture and packaging units of Fertilizers, Pesticides and Seeds and units related to the supply chain, raw material and intermediaries
- v. All harvesting cutting and farming operations / activities including agriculture labour (separate directions issued in this regard)

#### **5. Animal Husbandry, Dairy etc.**

##### **All activities – direct and related - permitted**

These also include:

- i. Veterinary medicines, clinics and hospitals etc.
- ii. Shops selling fodder, cattle feed (*Pashu Ahaar*) or poultry feed, depots and other outlets related to it.
- iii. Bee Keeping
- iv. All manufacturing units for cattle and poultry feed raw material, packaging and any other which is part of the supply chain
- v. Dairy – all activities of the supply chain pertaining to fodder, milk production, transportation, distribution and sale etc.

#### **5. Transportation:**


- i. Inter-State and Intra -State movement of all trucks and other goods carrier vehicles with one driver and one additional person is permitted.






- ii. Inter and Intra State movement of harvesting and sowing related machines like combined harvester and other agriculture / horticulture implements.
- iii. Offices / Godowns / Depots of Transport Companies with minimal office staff and labour for loading / unloading.
- iv. Workshops / shops for repair of trucks especially along highways
- v. Tyre / puncture repairing shops on highways at reasonable distances
- vi. Dhabas on highways on reasonable distance (eg. 40 kms) with outdoor eating facility spaced out.
- vii. Authorized Company service / repair centres for all kinds of vehicles that are permitted
- viii. Spare Parts shops for the transport vehicles permitted
- ix. Transit travel arrangements for foreign nationals in India / Indians returning from overseas, after completion of quarantine, as per SOP laid down by MHA.

For all such permitted activities, **the organizations /owners / employers must ensure necessary precautions against COVID-19 virus, as well as essential hygiene and social distance measures**, as advised from time to time.
