The Task Force is authorized to induct any Secretary to Government or other experts it deems appropriate.

The Task Force will submit its recommendations to the State Government within the next 2 -3 days for sending to the Government of India for consideration.

The Task Force may consider the following issues while making its recommendations in regard to the phased opening of the lockdown:

- (1) Geographical opening of areas within each State based on the reported cases.
- (2) Prioritization of units, establishments and offices in each sector, keeping in view both the medical safety issues as well as criticality from the economic activities etc. perspective.
- (3) Opening up of passenger transport services and personal vehicles.
- (4) Labour issues, considering the migration that has taken place from the work place and their return, lodging etc.
- (5) Health safety protocols that need to be prescribed for public when they come out, at work place and for travel.
- (6) Any other pertinent issues in this regard.

The Home Department, Government of Rajasthan will be the Administrative Department for this Task Force.
