**ORDER**

Sub:Unlock - 4 Implementation Orders for the period September 1st to September 30th, 2020.

Vide Order No.40-3/2020-DM-I(A) dated August 29th, 2020, Ministry of Home Affairs (MHA), Government of India has issued new guidelines for Unlock-4.

Accordingly, the following Implementation Guidelines are hereby issued in the State of Rajasthan for the period September 1st to September 30th, 2020.

**A. Lockdown limited to CONTAINMENT ZONES/ CURFEW AREAS:**

- (i) Lockdown shall remain in force in the Containment Zones till September 30th, 2020.
- (ii) Containment Zones shall be demarcated and notified by the **District Collector** concerned at the micro level after taking into consideration the guidelines of MHA/ Ministry of Health & Family Welfare (MoHFW) with the objective of effectively breaking the chain of transmission. Strict containment measures will be enforced in these Containment Zones and only essential activities will be allowed. There shall be strict perimeter control to ensure that there is no movement of people in or out of these zones, except for medical emergencies and for maintaining the supply of essential goods and services. In the Containment Zones, there shall be intensive contact tracing, house-to-house surveillance, and other clinical interventions, as required. Prohibitory orders

under Section 144 Cr.P.C will be issued by the concerned district authority.

- (iii) These Containment Zones will be notified on the websites by the District Collector concerned and information will be shared with MoHFW.
- (iv) The District Authorities shall not impose any local lockdown (District/ sub-division/City/ village level), outside the containment zones, without prior permission of GoI.

**No relaxations of any kind shall be permitted in the Containment Zones.**

**B. NEGATIVE LIST/ PROHIBITED ACTIVITIES:**

The following activities will continue to remain prohibited across the State till further orders:

1. Activities prohibited during Unlock 4 period outside the Containment Zones:
  - (i) Schools, colleges, educational and coaching institutions will remain closed for students and regular classes activity till **30th September, 2020**. However, following will be permitted:
    - a. Online/ distance learning shall continue to be permitted and shall be encouraged.
    - b. 50% of teaching and non-teaching staff to be called to the schools at the time for online teaching/ tele-counselling and related work, with effect from **21st September, 2020** for which SoP will be issued by MoHFW.
    - c. Students of classes 9 to 12 are permitted to visit their schools, in the areas outside the Containment Zones only, on voluntary basis, for taking guidance from their teachers. This will be subject to written consent of their parents/ guardians and will be permitted with effect

from **21st September, 2020** for which SoP will be issued by MoHFW.

- d. Skill or Entrepreneurship training will be permitted in National Skill Training Institutes, Industrial Training Institutes (ITIs), Short term training centres registered with National Skill Development Corporation or State Development Missions or other Ministries of Government of India and Government of Rajasthan.

National Institute for Entrepreneurship and Small Business Development (NIESBUD), Indian Institute of Entrepreneurship (IIE) and their training providers will also be permitted.

These will be permitted with effect from **21st September, 2020** for which, SoP will be issued by MoHFW.

- e. Higher Education Institutions only for research scholars (Ph.D.) and post-graduate students of technical and professional programmers requiring laboratory/ experimental works. These will be permitted by Department of Higher Education (DHE) in consultation with MHA.

- (ii) Cinema halls, swimming pools, entertainment parks, theatres, and similar places will remain closed. Open air theatres will be permitted to open with effect from **21st September, 2020**.
- (iii) International air travel of passengers, except as permitted by MHA.
- (iv) Metro Rail will be allowed to operate with effect from **07th September, 2020** in graded manner. In this regard SoP will be issued by MoHUA.
- (v) Social/ political/ sports/ entertainment/ academic/ cultural/ religious functions and other large congregations with a ceiling of **50 persons**, will be permitted with effect from **21st September 2020**, with mandatory wearing of

face masks, social distancing, provision for thermal scanning and hand wash or sanitizer. Prior information would have to be given to concerned Sub-Divisional Magistrate.

- (vi) **Marriage related gathering** may be held with following conditions; the organizer shall:
- give prior information to SDM
  - ensure social distancing during the function
  - ensure that the maximum number of guests allowed shall not be more than **50**.

- (vii) **Funerals/last rites** related gatherings shall ensure social distancing and the maximum number of persons allowed shall not be more than **20** till **21st September, 2020** after which ceiling of **50** persons will apply.

**Violation of any of the above conditions is an offence and punishable with heavy fine.**

**C. PERMITTED ACTIVITIES (CONDITIONAL) outside the Containment Zones:**

All activities permitted vide Order of even number dated May 31st, 2020 and Addendum dated June 6th, 2020, 30th June, 2020 and 30<sup>th</sup> July, 2020 and addendum dated 27<sup>th</sup> August, 2020 that is not in the negative list/prohibited activities category, shall continue to remain permitted with the restrictions/ precautions specified in those orders.

In addition, the following will continue to be permitted:

- Small places of worship** (temple, masjid, gurudwara etc.) **in rural areas**, which used to have an average daily visit of up to 50 persons per day, prior to the Lockdown, may be opened subject to the following conditions:

- (1) Entry of persons be staggered in such manner that the number of persons inside the place of worship at one point of time are limited to the extent that social distancing of at least 6 feet is ensured between each such person.
- (2) All persons inside such place shall necessarily wear a mask.
- (3) The SOP dated June 4, 2020 for religious places/ places of worship issued by Ministry of Health & Family Welfare (MoHFW), Government of India shall be followed to the extent it is practical for these small places of worship.
- (4) Any other specific directions issued by the Collector & District Magistrate, based on the recommendation of the District Level Committee on religious places in regard to the do's and don'ts to be observed within each kind of place of worship.

**All other places of religious worship viz. temples, mosques, churches, gurudwaras etc. shall be permitted to open from September 7<sup>th</sup>, 2020 with certain conditions/protocol as per guidelines dated August 27<sup>th</sup>, 2020.**

- 2. Shops** - Adequate physical distancing among customers will be ensured in the shops. No sale shall be made by the shopkeeper to any customers who is not wearing a mask.

#### **D. COMMON SAFETY PRESCRIPTIONS**

The following **standard SAFETY precautions and restrictions** shall remain **applicable** for all areas and all districts:

##### **1. IN PUBLIC SPACES:**

The following precautions, **being essential for public safety**, are mandatory and **violation** of the same shall be **punishable with fine**.

- (1) **Face Covering:** Wearing of face cover is compulsory in all public and work places and during public transport.
- (2) **Social distancing:** Each person shall maintain a distance of 6 feet - "do gaz ki doori") in public places.
- (3) **Spitting in public & work places is prohibited** and punishable with fine.
- (4) Consumption of liquor, paan, gutka, tobacco etc. in public place is prohibited and punishable with fine. **The necessary compliance would be ensured as per regulatinos made under section 4 and 11 of the Rajasthan Epidemic Diseases Ordinance/Act, 2020.**
- (5) All persons are advised to wash hands with soap & water / use sanitizer after touching any surface that is in public contact.

## 2. AT WORK PLACES:

In addition to 1 above, the following additional safety precautions are prescribed **for WORK PLACES** (Offices, Establishments, Factories, Shops etc.):

- (1) **Work from home (Wfh):** As far as possible, the practice of work from home should be followed.
- (2) **Staggering of work/business hours** will be followed in offices, work places, shops, markets and industrial and commercial establishments.
- (3) **Screening & Hygiene:** Provision for thermal scanning, hand wash and sanitizer will be made at all entry and exit points and common areas.
- (4) **Frequent sanitization** of entire workplace, common facilities and all points which come into human contact eg. door handles etc. shall be ensured, including between shifts.
- (5) **Social Distancing:** All persons in charge of work places shall ensure social distancing between workers, through adequate distance between workers, adequate gaps between shifts, staggering the lunch breaks of staff etc.
- (6) All employers shall encourage and motivate their employees to install, and use, on their mobile phones, *Arogya Setu* for common and personal safety.

- (7) Intensive communication and training on good hygiene practices shall be taken up.

The District Magistrate and other authorized officers shall **enforce Common Safety Prescriptions**, as stated above, **through fines and penal action** as prescribed in the **Disaster Management Act, 2005/The Rajasthan Epidemic Diseases Ordinance/Act, 2020**.

### 3. SAFETY ADVISORY FOR VULNERABLE PERSONS:

Vulnerable People (Persons aged 65 and above, Persons suffering from Chronic diseases/co-morbid conditions, Pregnant women and Children below 10 years) are strongly advised to **stay at home** and move out only for essential and health purposes. Out of home, it is most essential that they exercise utmost safety precautions as specified.


### E. MOVEMENT OF PEOPLE/TRANSPORT/PASSES:

- (i) There shall be **no restriction on inter-State and within State movement of persons and goods**.
- (ii) All **commercial passenger transport vehicles** - bus, taxi, cab aggregators (OLA/Uber etc.) auto rickshaw, cycle rickshaw - are also permitted to ply subject to **ensuring proper sanitization of the seats and touch points before and after each journey** and other safety precautions prescribed.
- (iii) Public (City) Transport as permitted vide Orders No.F.33(2)Home/Gr.9/2019 dated 22nd July, 2020 shall continue to remain effective.
- (iv) **The passengers** travelling in any vehicle (personal or commercial) **shall not exceed the permitted seating capacity** of the registered vehicle.
- (v) Movement by passengers trains and domestic passengers air travel etc. will continue to be regulated by the SOPs issued by MHA, Government of India.
